SNOWMOBILE ROUTE ORDINANCE  
Ordinance # 2-99  
As amended through May 12, 2012

Adopted April 13, 1999

The Town Board of the Town of Hayward does ordain as follows:

Authority:

The Town Board of the Town of Hayward, Sawyer County, Wisconsin, has the specific authority under Section 350.18(3) (a), Wisconsin Statutes, to adopt this ordinance.

1. That the following named roads in the Town of Hayward shall be designated as snowmobile routes, between those areas posted as such with snowmobile route signs:
  - a. Chippewa Trail
  - b. Conger Road
  - c. Fairway Drive (formerly Water Tor)
  - d. Kadlec Road
  - e. Park Road (formerly Trailer Court)
  - f. Ranger Station Road
  - g. Osprey Rd
  - h. Vogel Road
2. The speed limit shall be 25 miles per hour while operating on all Town of Hayward roads and streets. Note: State Law restricts snowmobile speed to 10 mph within 150 feet of a dwelling between the hours of 10:30 p.m. and 7:00a.m.
3. Snowmobiles shall operate on the extreme right side of the roadway and travel with the flow of traffic.
4. Snowmobiles are to be operated in single file.
5. Snowmobile operators shall yield the right-of-way to all other vehicular traffic and pedestrians.
6. Headlights shall be turned on and in working order at all times while operating on the roadway or shoulder.
7. Paragraph 7 of Ordinance #2-99 is deleted and is hereby repealed.
8. Snowmobilers travel at their own risk and the Town of Hayward will not be liable for any damages or injuries to snowmobilers occurring in the Town of Hayward
9. The Town of Hayward Police Department, the Sawyer County Sheriff's Department and the Wisconsin Department of Natural Resources are the designated law enforcement agencies responsible for enforcing the provisions of this Ordinance.
10. The penalty for violating any of the provisions of this ordinance shall be the sum of \$50.00, plus court costs and the costs of prosecution.

SNOWMOBILE ROUTE ORDINANCE

11. This Ordinance shall be effective upon passage and publication as provided by law and shall repeal and replace all snowmobile route ordinances heretofore enacted by the Town of Hayward, and specifically repeals Ordinance #12 entitled "An Ordinance Regulating the Use of Snowmobiles Within the Limits of the Town of Hayward" passed by the Town Board of the Town of Hayward on October 11, 1983.

Severability:

If any provision of this ordinance or its application to any person or circumstance is held invalid, the invalidity does not affect other provisions or applications of this ordinance that can be given effect without the invalid provision of application, and to this end, the provisions of this ordinance are severable.
