









Proposed East Elevation




Phase 3-A

Proposed Alterations to Existing Facility

This phase includes alterations that include repair to structural items, replace concrete floors to accommodate proper drainage, new overhead doors to accommodate large vehicles, handicap toilet room and Building Code upgrades. Mechanical/Electrical work to include replacing water heater, providing garage floor wastewater treatment, upgrading HVAC equipment, replacing power distribution equipment, and upgrading lighting with high efficiency LED lighting. This phase assumes that Phase 1, at a minimum, will be completed.

Mechanical/Electrical work to include NFPA 13 fire suppression system; plumbing fixtures, equipment, specialties, and piping; high efficiency HVAC systems including furnaces and radiant floor heating; and electrical power distribution, outlets, and high efficiency LED lighting. This would be an addition to Fire Department facility in lieu of Phase 3-A.



This phase includes the construction of an asphalt-paved floor with poured concrete frost footings and foundation wall, concrete and metal frame structure, with associated electrical as needed.

<u>Summary</u>

Total costs of all phases for proposed construction range from **\$2,565,700** (Phase1 & Phase 3A) up to **\$5,052,100** (Phase 1, Phase 2, Phase 3B and Phase 4).

Ongoing monthly to annual costs that will need to be budgeted are as follows:

- Municipal Water and Sewer from City of Hayward.
- Additional phone/data for sprinkler system monitoring.
- Sprinkler system inspection/certification.
- HVAC equipment maintenance.
